<ul style="list-style-type: none"> <li>• Part 1: 24 hours of classroom and 6 hours of behind-the-wheel instruction (Green Certificate)</li> <li>• Part 2: 6 hours of classroom instruction (White Certificate)</li> <li>• There must be a 90-day span between the completion of Part 1 and the start of Part 2</li> <li>• 30 hours of driving time with a parent/guardian</li> <li>• Students must be 14 years and 8 months old to apply for Part 1</li> </ul>	<ul style="list-style-type: none"> <li>• Green Certificate must be validated by the Secretary of State's Office</li> <li>• Students must pass Part 1 and Part 2 Driver's Education</li> <li>• 50 hours of driving time with a parent/guardian</li> <li>• There must be a 6-month span between the Level 1 license and Level 2 license</li> <li>• Students must pass a road test</li> <li>• Students must be 16 years old</li> </ul>
